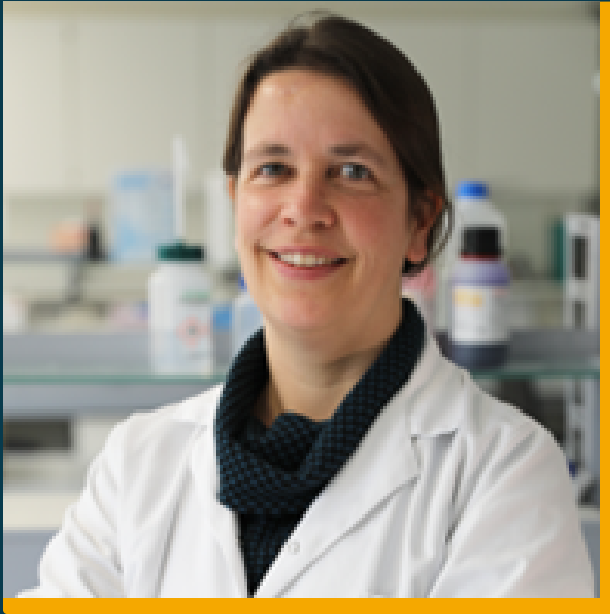

The Austrian Early Childhood Interventions Programme was developed on the basis of such a comprehensive approach by our team in 2011 and aims to promote health equity in the long term.
