Patients as experts: to identify unmet service and therapeutic needs and point out inefficiencies and waste in systems and processes

Health Literacy and Participation in Austria



- The level of health literacy is diverse between population groups, which contributes to health inequalities
- 56,4% of Austrians have an inadequate or problematic health literacy level (2012)
- Although many initiatives take place, health literacy needs to be strengthened in Austria
 - Strengthening citizens' health competence is one of the ten main health targets (Austrian Federal Ministry of Health)

Leading **patient organisations influenced** all of this legislation.

Patient engagement is also crucial in effective **implementation**, through EMA and at national level

Pricing and Value



EPF Preliminary Statement

- Distributed in advance on Informal Health Council 15 April ongoing discussions
- Key concerns regarding current pricing models which contribute to inequities
- A patient perspective on the 'value' of innovation
- Core principles for the pharma industry, and political decision-makers to ensure equitable access to treatment based on need, not means, + long-term sustainability of our health systems

Value and Fair Price of Innovation



- Some of the main challenges for Austria
 - 1. high-priced medicines
 - 2. cost pressure in cases involving broad indications
 - 3. "life-style" medicines
 - 4. relationship between cost and benefit
- Patients' voice is not heard in regulatory or access processes
- Time to market: short time span until innovations become available on the Austrian market, but access to innovation is not equally distributed

The Patient Access Partnership



The Access Partnership

Working towards a European Partnership for equity of access to quality healthcare



A multi-stakeholder partnership with patients, healthcare professionals, healthcare industries, and health experts, and key decision makers

Objectives

- Join forces to measure, map and explore solutions to overcome inequities, based on individual and collective expertise
- To put the issue higher on the EU political agenda

A patient led campaign on access 2017



Huge disparities across the EU and within countries, austerity measures have widened the gap

"Healthcare coverage is universal or almost universal in all Member States" (EC, 2014)

≠ not our experience

Patients face multiple, concrete barriers to access, yet the European approach is focusing primarily on health determinants

Economic imperatives are overshadowing the cost of health inequalities, which is both financial and human

Our main theme: The road to universal access in the EU by 2030

- UN sustainable development goals in health : universal health coverage by 2030
- To show that we are still far from it... regardless of whether it is
 - the population covered
 - the type of services
 - or the proportion of costs that patients pay
- To define **concrete steps that need to be taken by 2030** to be on the right track
- A long term vision where equity of access becomes a reality

MIGRATION, NON-DISCRIMINATION AND INCLUSIVENESS

Health system challenges for migrants in Austria



- Rapid increase of migrants: +10,6% in 2015 (Statistics Austria, 2016)
- In principle healthcare is accessible for migrants, however following challenges exist:
 - Low level of health literacy
 - Intercultural communication with health personnel
 - Unmet needs for psychosocial support → start of new initiative (CARE, 2016)

Patients and discrimination: the picture today

- Strong link between discrimination and health inequalities
- Patients stigmatised and discriminated because of disease: e.g. HIV
- Age also a factor of unmet need and stigma: both for older and younger patients.
- **Gender:** Inequalities in research, gender labelling of diseases

Patients and discrimination: the picture today (2)



- Mental health: Denial of adequate examination, lesser monitoring of physical conditions
- Disabled people: denial of treatments because of assumptions on quality of life and access related barriers
- Sexual orientation: Status of the partner?
- Ethnicity: Stigma
- Strong evidence that some groups like the Roma people and undocumented migrants face barriers to access, and exclusion

Health for All



- EPF position "health for all" defines principles we stand for + recommendations for decision makers in 5 domains:
 - Right of access and equal treatment <u>for all</u>
 - Right to be protected from discrimination <u>based on health status</u>
 - Right to respect and to dignity in healthcare facilities
 - Right to information and support
 - Right of "vulnerable" groups to participate in non-discrimination policies



EPF's work on migration with partners

- Joined the Fundamental Right Platform of the EU Fundamental Rights' Agency in 2011
- Collaborated with 11 NGOs on a common statement on discrimination in healthcare sent to MEPs in 2014
- Joint NGO statement to the Council on the migrant crisis in June 2015 to call on Member States to challenge migration policies that undermine public health objectives

Looking into the future



- Developing internal EPF **roadmap** to define concrete actions to improve inclusiveness
- Aim: structured **cooperation** with organisations representing groups potentially vulnerable to discrimination
- An initiative driven by EPF members with expertise and interest in this area
- Direct dialogue between key NGOs
- To identify synergies between the patient movement and NGOs fighting discrimination





- Promoting the right of undocumented migrants to full access to healthcare, and raising awareness of barriers they face legally and in practice.
- Exploring the link between undocumented migrants status and experience with mental health, promoting access to mental health care
- Older undocumented migrants and disabled undocumented migrants: promoting access to health and social care
- EPF's work on transition to adult care: include the rights of child migrants to keep their entitlement to healthcare into adulthood

Conclusions

- Patient Empowerment, and Patient Access inextricably linked
- Multi-stakeholder collaboration shared learning – thinking and doing things differently.
- 'Full circle' approach the national dimension is vital
- Moving towards an EU framework on non-discrimination on the grounds of health status
