28 July 2021, Bad Hofgastein, Austria – The European Health Forum Gastein (EHFG) 2021 edition, “Rise like a phoenix – Health at the heart of a resilient future for Europe” sets itself the clear objective to call for more solidarity, equity, and transformation in health, within Europe and on the global stage. With its renewed ambition for enhanced stakeholder collaboration and policy-shaping, the EHFG 2021 edition will feature a series of online sessions over five days and run from **27th September to 1st October 2021**.

While Europe is now progressing well with the roll-out of its COVID-19 vaccination strategy, a large part of the world is still grappling with the challenges of access to vaccines and therapeutics. The EHFG 2021 will bring together stakeholders to discuss how Europe and the rest of the world can rise from this crisis as more resilient, smarter, and more equitable societies.

The first plenary will reflect on ways for Europe to better cooperate on the international stage and strengthen true multilateralism, to better prepare for future crises. The second plenary will provide an integral part of the Conference on the Future of Europe. As such, it will offer a unique opportunity for civil society actors and citizens at large, to co-develop a shared vision on health and solidarity in Europe. The third plenary will explore what a renewed social contract could look like, with more inclusive, equitable, and sustainable policies.

The EHFG 2021 will also feature a variety of thematic sessions, which will be grouped under four tracks: transforming tomorrow (1), complex systems (2), joining forces for health (3), and levelling up together (4). Sessions in the first track will consider approaches with transformative potential in areas like health systems resilience, cancer care, data governance, rare diseases, and digital health. The second track will discuss future visions for the healthcare workforce, healthcare financing, healthy economies, the climate crisis, and more. The third track will envision a healthier and more resilient Europe in solidarity with the rest of the world and dive into new models of collaboration.

Finally, the last track will consider how to empower communities, improve communication between experts, decision-makers and citizens, and make marginalised voices heard to lead the way to a more equitable tomorrow. Overall, the above-mentioned tracks will aim to highlight challenges pertaining to the management of “poly-pandemics”, comprising multi-faceted crises which contain environmental, economic, democratic challenges, and the widening divide between rich and poor.

Leading experts traditionally participate in the annual conference held in the Gastein Valley in the Austrian Alps in late September/early October. Since 2020 and due to COVID-19, the conference is being held in a fully virtual format and has been extended from three to five days in its 2021 edition.
